DotHouse Health Awarded Nearly \$80k in Grants through the Health Resources and Services Administration

DotHouse Health was awarded nearly \$80,000 in Affordable Care Act grants as part of a Health Resources and Services Administration (HRSA) project to recognize high performing health centers. DotHouse Health is dedicated to providing smarter care by acting on quality improvement strategies.

"These funds acknowledge the tremendous work our providers and staff do every day to promote good health in our community," said explained Michelle Nadow, Interim CEO of DotHouse Health. "We appreciate HRSA's investment in our ongoing mission of providing quality, accessible care that helps to reduce health risk disparities in Dorchester."

DotHouse Health was awarded HRSA grant funding in the following categories: Electronic Health Record Reporting, Clinical Quality Improvement and Health Center Quality Leaders. The community health center received funding by demonstrating improvement in clinical quality measures between 2013 and 2014. Improvements were seen in weight screening and follow-up for adults and adolescents, and treatment of cholesterol. DotHouse Health was also recognized as a Health Center Quality Leader by achieving the best overall clinical outcomes among all health centers and demonstrating a dedication to quality in all aspects of clinical operations. DotHouse was recognized for outstanding clinical outcomes in access to prenatal care, colorectal cancer screening and several chronic disease measures, including diabetes control.

Health Center Quality Improvement Awards totaled \$63.3 million in Affordable Care Act funding and were distributed to 1,153 health centers in all 50 states, the District of Columbia, and 7 U.S. Territories to recognize health center achievements in providing high quality, comprehensive care. Health centers will use these funds to expand current quality improvement systems and infrastructure, and improve primary care service delivery in the communities they serve.
